Origin: - Swami Nityananda Brahmachari came like a "trailing cloud of glory" from Sargashram (Haridwar/Hrishikesh) and became enamoured with the shape of the then Patra (a sprawling land), purchased it from its owners, the local Mukherjee family and christened it 'Manbhum Ananda Ashram'. Like a true svant he espoused the cause of the local people then groveling in the quagmire of poverty, superstition and lack of educational facilities. The panacea he sought for and found was the spread of education. He founded a 'Chatuspathi' and that turned out to be a torch to dispel the surrounding gloom and darkness. In fact, the Trust was in its embryonic form in his lifetime and on his demise it was registered as 'Manbhum Ananda Ashram Nityananda Trust' bearing Registration No. S/3863 of 1959-1960. Our 'ZERO HOUR' commenced accordingly.

## **Historical Development**

The mantle of glory of the deceased svant was then fittingly donned by his worthy disciple Late Sri Harihar Mukherjee, an undaunted social activist with a checkered career. He started where the svant had stopped. Challenges and odds were very many there but the determined visionary in him took arms against the sea of troubles. Like the proverbial crow Sri Mukherjee had his will and he found the way. Swamiji had his Chatuspathi - a flickering lamp against blast from all corners. Like the 'Jeevan Deep' symbol Sri Mukherjee guarded it with his hands cupped and helped it glow more and still more. Under his leadership a High English School was started on 1st January, 1940. But was a long patient and strenuous travel from pillar to post in search of resources. He di not aspire for any princely donations from the then colonial rulers instead he went to common people with his mission to be with them expecting them to be with him. They were. They contributed their mites to translate his Guru's long cherished dream into a reality. Under the aegis of the Trust, blessed with the founder secretaryship of Late Sri Harihar Mukherjee, an educational complex has since been developed through the years in the Manbhum Ananda Ashram with the following educational units —

- Laulara Radha Charan Academy A Co-educational High School
- Vivekananda Jr. Basic School
- Subhasini Pathagar Rural Library Naba Sishu Niketan Pre Basic Nursery Manbhum Ananda Ashram - Girl's Jr. High School and
- Ramananda Centenary College A Degree College in Arts and Science

And in the year 1994 the Trust re-lidded and tightened its belt with an unrelenting vigour and determination to be instrumental in bringing about a sea change in the social sector as it had successfully done in the Education sector. Accordingly the Trust was revitalized and our 'Zero Hour' commenced a new.

## THE YEAR IN RETROSPECT

## Name of the Activity: Mobile Medical Clinic

MANT has been entrusted to implement the Mobile Medical Camp Project in 9 Blocks namely, Garbeta-II, Sankrail of PaschimMedinipur, Ranibandh of Bankura, Manbazar-II, Bandowan, Bagmundi and Jhalda-II of Purulia and Dhupguri and Madarihat of Jalpiguri. The projects got initiated in the last week of January 2012. While 10 more MMCs were initiated in the Blocks of Raipur and Sarenga of Bankura, Binpur-I and II, Gopiballavpur-II and Jhargram of Paschim Medinipur and Rajganj, Matiali, Nagrakata and Kalchini of Jalpaiguri on August 2012. Later an MMC has got started to operate in the Village of Amalasole of Paschim Medinipur in Decmber 2012. In 2013 the Bagmundi and Sarenga MMCs of Purulia and Bankura respectively were discontinued and in Simlapal of Bankkuura an MMC got started to operate from 2nd May 2013.

### Type of services being provided

Reproductive & Child Health Services:

 Provision of doctor to attend mothers and children referred to the camp by the ANMs /other local health workers, or self driven attendance, seeking services related to the reproductive and child health including ante natal and post natal check-up



- Treatment of common childhood illness such as diarrhoea, ARI / pneumonia, etc.
- Treatment of RTI /STI and counselling thereto
- Treatment and counselling of adolescent girls and women of the reproductive age group.
- Temporary methods of family planning (CC&OP) including counselling.
- Temporary methods of family planning (CC&OP) including counselling

#### Curative:

- Treatment of minor ailments for all attending the camp.
- Minor surgical procedures and suturing
- Early detection of TB, Leprosy, Malaria, Kala-Azar, iodine deficiency, RTI/STI, adolescent anaemia, risky pregnancy, post-partum problems, sick neonates, diarrhoea, severe & acutely malnourished (SAM) children and other locally endemic communicable diseases and non-communicable diseases such as hypertension, diabetes and cataract cases etc.



- Eye check-ups and referral
- Referral of complicated cases

## Name of the Activity Tobacco Control Project

MANT has been implementing The Union supported tobacco control project under FCRA in 5 districts of West Bengal since 2014. However, in this financial year MANT has been actively involved in 6 more districts of West Bengal to lend active support to the government initiatives, as annowhen so sought for, relating to tobacco control in general and enforcement of provisions of COTPA, 2003 and its subsequent rules at the district level in particular.

#### Objectives:

- To establish a politico-administrative and infrastructural framework for tobacco control in the State of West Bengal
- To build capacity of the stakeholders to implement COTPA, 2003 through strengthening of the institutions involved.
- To establish a comprehensive COTPA enforcement mechanism at District and sub-district level.
- To create a functional tobacco control network and coalitions at state and district level
- To develop and implement a public education media and communication strategy
- To identify and initiate action at the gubernatorial stage on tobacco industry interferences aiming to hinder tobacco control agenda
- Conduct strategic policy focused research, monitoring and evaluation

## Name of the Activity Adolescence Health Training

Two purposive Training Programs on Adolescence Health were conducted with support from Vigyan Prasar, Department of Science and Technology, Government of India, to trigger of awareness on adolescence health and the related issues among the target group.

#### Date and Venue

- 1. 17th and 18th December,
   2016 at Basudeb Lodge in Jalpaiguri District, West Bengal
- 2. 9th and 10th January, 2017 at Laulara R.C. College Campus in Purulia District, West Bengal

#### About the Program:

The motto of the training was to generate awareness among the adolescent girls regarding the specifics. physical, mental and psychological, of adolescence period, the connected health issues and the nutrition intake supposed be required during that period and simultaneously to make them concerned about the ill effects of the early child hood marriages willy nilly perpetrated on them.

### Scope:

The objectives of the training were as follows:

- To enhance the knowledge level of the tribal adolescent girls on adolescence in ggenneral with special emphasis on the changes that happen to them during adolescence e.g. menstrual hygiene, nutritional status etc.
- To sensitize tribal adolescent girls on different types of adolescent related government programme.
- To implant and stimulate in them Leadership Quality, and a keenness for Social Participation
- · To aware adolescent tribal girls about social evils and their ill effects.
- To strengthen and enable them to counter the social evils

#### Target Group and Training Methodology:

- Target group of this awareness training programme was the teen aged tribal adolescent girls. A total of 120 adolescent girls were chosen for training from different blocks of Jalpaiguri and Purulia with the proportion of 60 each per district.
- To assess the awareness status of the target group, MANT conducted a
  pre-test survey before the training session. Relevant and effective topics and
  issues were singled out through methodical process for this awareness
  programme.
- Appropriate resource persons were being selected for conveying the requisite knowledge among the target group.
- After the training session, a post test survey was conducted with the same questionnaire to figure out the increasing knowledge level of the target group.




#### Content of the Training Programs and List of Resource Persons:

### Name of the Activity: Self Help Group

#### INTRODUCTION:

MANT has been actively working for economic & social development of the rural women through formation, stabilization and strengthening of Self Help Groups. The Organization believes that SHG is one of the key instruments for empowering women of the marginalized section of the society and has been effectively functioning on this issue for the last two decades. MANT has been organizing & conducting several skill & capacity building training programs, workshops, group discussions for Self Help Groups with the objective of creating in them a general consciousness & awareness on social issues, providing information on different income generation activities, imparting requisite skill and knowledge to tap and manage the productive natural assets and become self-reliant to increase the access to & control over natural resources.

#### **ACTIVITIES:**

MANT has been working in joint collaboration with the Directorate of Sericulture, Govt. of Nagaland under Intensive Bivoltine Sericulture Development Project in the selected blocks of Dimapur District (Dhansiripar & Medziphema). Programmes that have been conducted during the period in question in Two Blocks i.e. Dhansiripar & Medziphema covering 600 beneficiaries are given below in tabular form.

## Name of the Activity: Livelihood Promotion and Woman Empowerment

#### A New Initiative :

Prantika — A Training cum Garments Production Centre, managed by exclusively Tribal Women, has been established at Majgerya Police Camp under Barikul PS, Bankura with infrastructural support from Bankura District Police. The unit has been inaugurated by the SP, Bankura Mr. Sukhendu Hira, IPS on 17.09.2016.

The primary objective of the unit is to help the tribal women attain self sustenance and economic growth through skill upgradation programs and thereafter show case & commercialize the end products to the general market thus strengthening the socio-economic standard of the communities.

Two full time Trainers has been appointed for providing handholding support to 20 tribal women for fabric production. The unit is producing cotton & linen fabrics for developing Kurtas & Shirts.

# Name of the Activity Nityananda Janavani 91.2 F.M CRS

#### Major Objectives:

i. Build up awareness, through the mode of education and entertainment (EE) designed by, for and with the community.

ii. Understand the social problem in all its complexities and simplify it into an easily transferable message.

#### Target Areas and People:

The radio, in fact, a Communication for Development (C4D) initiative for mass reach – the only option available in this under-developed zone of a legendary backward district – that aims at making life – enhancing, life – saving knowledge easily available to everyone living within a radius of 15 km.









#### Activities and Achievements of Last Financial Year:

#### Program Duration:

The program is being broadcasted everyday for 4 hours from 3 pm to 7 pm—2 hours specified for Bengali and Santhali versions each. In case a listener misses to listen it at the scheduled time, a repeat is being broadcasted from 7 am to 11 am on the very next day.

The entire service is an initiative taken to fight perpetual poverty and backwardness in the marginalized area. It is an approach to help the underprivileged to sustain an upgraded lifestyle triggering social crises at different layers.

#### Hours of Production:

Almost 950 hours of production have already been broadcasted in the last year.

#### People Reached:

Approximately 70000 people were reached in the last year through radio programmes and campaigning.

#### Meetings on Sustainability:

have Several meetings been arranged and held with the Government Officials and Block Development Officials regarding the financial matters along with advertisement and promotion. MANT from their side has met with other business organisations and has been keeping contact with them. But the procedure will take place only after completion of the administrative remaining formalities and starting of the regular broadcasting.





#### Campaigning:

Several campaigning program were conducted to promote the listenership of the CRS throughout the whole coverage area. All the members of Nityananda Janavani Community Radio including the Station Manager, Producers and RJs participated in this campaign process at different places of the coverage area. They campaigned through Sound Clippings to grab attention of the people and live demonstrations of playing and tuning radio was also shown to them through mobile phones. T-shirts and Caps containing the name, logo and motto of Nityananda Janavani CRS were distributed through quiz contests which had questions related to radio, communication and current affairs.

An efficient team at the core position of the CRS tackles the mechanism at different levels. An employee strength of 22 works at the grassroots level. They put in best efforts for the program's success in the long run.

# Name of the Activity Workshops on Tribal and Folk Music

Cultural traditions from various regions of the state of West Bengal reflect the rich diversity of Regional Music of the state. Each region has its own particular style and Jangalmahal is no different.

Tribal and folk music are not taught in the same methodical way that Indian classical music is being taught. The musical practitioners must still attend to their normal duties of hunting, agriculture or whatever their chosen profession is. In addition, over the years the traditional way of singing and the knowledge on folk music has become concentrated on few locally gifted people. Against this backdrop two workshops, namely Aadi-Raag (Workshop on Tribal Music) and Pranta-Raag (Workshop on Jhumur, Tusu and Bhadu Music) were organized by MANT in collaboration with Ramananda Centenary College, Laulara, Purulia to popularize and perpetuate the traditional way of singing among the young people and to preserve the distinct cultural pattern and instinct of the people from the cultural onslaught of other extraneous forces living in the margins.

#### Achievements:

The participants learnt and realized the rendition process and breath control in presentation of songs. The rich cultural heritage of Rural Purulia now on verge of extinction emerged as a living force to the learners and they almost vowed to preserve the traditional songs and tunes so that the extinct cultural tradition could be revived and resuscitated to a new dimension and gather the inner strength to withstand the buffets of time and the invasions of extraneous cultures. This also produced a pool of singers who would sing for the Nityananda Janvani, the CRS.

# Name of the Activity Use of Mobile Messaging ("Pranta-Kotha" Mobile Radio) for Awareness Campaign

The technology used is a basic 'mobile radio' system, which allows online uploading of audio content, made available to phones through a push-call (server calls stored numbers) or missed call (users place a missed call to servers and receive a call back). All users are able to listen to messages, browse older messages, and respond to messages by numeric input or voice recording. All call data and responses are made available on an online reporting dashboard immediately. Content shared on the platform will include curated 2-3 minute audio clips in the form of informational broadcasts or edutainment messaging, depending on the audience.

## Name of the Activity "Adolescent Intervention Program"

MANT (Manbhum Ananda Ashram Nityananda Trust) works as the Thematic Partner for the Communication Part of the Adolescent Intervention Program (AIP) at Purulia District of West Bengal. The proposed thematic project is about ICT initiative wherein the adolescents are in the central to air their voices and choices and thereby they can identify their own-self in their respective perspective. Here videos and audio clips have been produced at the community level on the issues like government schemes, importance of education, child marriage prevention, health, nutrition education, abuse and like and will be screened or played at the community by the trained adolescent volunteers.

#### Objectives :

- 1. To ensure that a network of adolescents participates in the design, implementation, monitoring and evaluation of the project's activities in the selected Blocks.
- 2. Promote the rights of adolescents and youth to information and freedom of expression as stated in articles 12 and 17 of the CRC through the ICT Initiatives.
- Strengthen the capacity of the Local Governments to protect the rights of the adolescents in the areas of survival, development, protection and participation.



#### · Activities :

#### I. Video Production

A total of 8 Community Video Volunteers have been taught to use and handle DSLR camera. They have shoot 4 videos already which are on different social issues like Early Child Marriage Prevention, Menstrual Health and Hygiene, Kanyashree Club and Importance of Kanyashree Towards Education.

#### II. Capacity Building

i. A total of 16 adolescents have been trained through RJ and Anchoring Training Program.

ii. A total of 25 adolescents have been trained through Training Program for Mentors.

#### III. Audio Magazine Preparation

8 audio clippings of 10 minutes' duration have been prepared among which 4 are in Bengali and 4 are in Santhali.

#### · Target Areas and People :

Adolescents of 4 Blocks (Hura, Manbazar-2, Barabazar, Baghmundi) and 3 Municipalities (Jhalda, Purulia and Raghunathpur) of the district of Purulia.



## Name of the Activity Santhali Book Fair in Purulia

To cater the thirst for knowledge among the Santhali Tribe, MANT Kolkata in collaboration with Ramananda Centenary College organised a Santhali Book Fair on 9th and 10th January, 2017 at Ramananda Centenary College Campus, Laulara, Purulia which was very first of its kind in the district. A number of Santhali publishers from Purulia, Bankura and Paschim Medinipur put up their stalls at the fair ground with great enthusiasm. There were 20 stalls in the fair along with Santhali Books with other various items like tribal handicrafts, dresses prepared by the tribal Self Help Groups etc. The theme of the fair was to getting back to the root. So the stalls were prepared in such a way which reflected the Santhali culture. Besides, famous folk and tribal artists performed there every evening.



### Name of the Activity Total Sanitation Scheme

Construction of 160 numbers of Sanitary Units has been done which clearly indicates people's reluctance in this issue.

#### Research project:

#### Reporting Period: 1st April, 2016- 31st March, 2017.

1. Short term impact of gutkha ban on tobacco consumption behaviour in West Bengal.

#### Study Area:

Bankura, Purulia, PaschimMedinipur

#### Nature of Work:

The PAN India study conducted in 3 states namely Punjab, Kerela and West Bengal. The West Bengal part was carried out by Research team of MANT.

Duration: April-July, 2016.

Objectives: To assess the perceived change of the ban on Gutkha/Chewable tobacco on tobacco consumption behaviour of tobacco users West Bengal.

To assess compliance of tobacco vendors to ban on sale of flavoured/ scented chewable tobacco/ guthka in West Bengal.

#### Findings:

#### Major findings on Vendors:

- 68.5 percent vendors replied that Gutkha is easily available to them
- 75.3 percent vendor sell gutkha to the minors.
- 75.3 percent vendor replied that Gutkha was more profitable than Gutkha like new tobacco mixture.
- 15.7 percent vendors shifted to other business after gutkha ban.
- Only 1.1 percent tobacco shop raided by Govt. officials after Gutkha Ban.
- According to 53.5 percent vendors their Gutkha consumers were shifted to other tobacco products.
- 92.1 percent of vendors felt that Gutkha Ban is helpful for quitting Gutkha and 95.3 percent of the Vendors have supported Gutkha Ban.
- In PaschimMedinipur, 45.5 percent vendor replied that new Gutkha like products more profitable than Gutkha.
- Gutkha Ban cause loss to 42.9 percent vendors in PaschimMedinipur, 35.7 percent in Purulia and 21.4 percent respondents in Bankura.

#### Major Findings of Consumers:

- 64 percent tobacco consumers know about Gutkha ban.
- Tobacco consumers from PaschimMednipur (72.1percent) was more aware about Gutkha ban than other study area.
- Average Consumer of Gutkha in Bankura was 19.96 percent, 19.2 percent in Purulia and 19.16 percent in West Medinipur.
- 43.8 percent in Bankura, 43.8 percent in Purulia and 31.8 percent gutkha consumer in West Medinipur were tring to quit ghutkha after Ban.
- At Present, 45percent, 37percent & 47percent of the respondents in Bankura,
   Puruliya & West Medinipur respectively told that they have stopped taking Gutkha.
- 32.2 percent Gutkha consumer economically gained after Gutkha Ban.
- 30 percent respondents increased their expenditure on other tobacco products.
- · 88 percent of the tobacco consumers have supported the gutkha ban
- 58 percent of Gutkha consumers were shifted to other tobacco products after Gutkha Ban.
- 2. Impact of Out of Pocket Expenditure for health care on the living standard of the Tribal people in West Bengal.

Area of study: Purulia, West Bengal.

Nature of Study: Research work

Time of the Study: May - June 2016

Objective: to see how the expensive health care expenditure is affecting the living standard of the tribal peoples.

Results: The health insurance of the Tribals, their household expenditure, cost and management of their health expenditure are the important variables those are considered for the analysis. Lastly the findings explained that the treatment cost had been an added burden on the low income tribal population and they managed it by paying cost through borrowing

## 3. Effect of Capacity Building training on knowledge level of Rural SHG member of Nagaland.

Study area: Medziphema Block, Nagaland

Nature of Work: Evaluation study.

Duration: June-July, 2016.

Objectives: To know the impact of Capacity building training on the SHG members of Nagaland.

Results: The results of the study which was showed positive and significant effect of capacity building training on knowledge level of SHG members on diffrent SHG related affaires was shared with Ministry of Textile, Govt. of India and Directorate of Sericulture, Govt. of Nagaland.

4. Leading Brands of Cigarettes, Bidis & Smokeless Tobacco Fully Compliant with new 85% Pictorial Health Warnings in West Bengal.

Study Area: Kolkata, West Bengal

Nature of work: Data collection and primary report preparation of PAN India study organised by Voluntary Health Association of India.

Duration: August- September, 2016.

Objective: To know the status of Pack warning of different tobacco products in the state of West Bengal.

#### Major Findings:

\*66% of the cigarette packs were fully compliant with all the labeling requirements of the law: graphic, text content, location (front & back and top of the pack), and size (85 percent of the principal display area) of the health warning labels.

\*Every pack of all purchased 13 bidi brands (all non-identified bidi companies) were non-compliant and were not implementing 85 percent pictorial health warnings.

\*27% of the smokeless tobacco packs displayed a pictorial and text health warning label that covered 85 percent of the principal display area of both sides of the pack.

Note: The data set has sent to the VHAI, New Delhi for further evaluation and reports.



5. Assessing the current level of Compliance for the Sections of 4, 5, 6, 7, 8 & 9 of COTPA, 2003 in Darjeeling District of West Bengal.

Nature of work: Research study.

Study area: Four sub-divisional head quarters (Darjeeling, Kurseong, Kalimpong and Siliguri). Matigara and Kurseong Block of Darjeeling district.

Duration: December, 2016-January, 2017.

Objectives: To know the status of compliance of Section-4 of COTPA in Darjeeling District of West Bengal.

Techical support: International union Against Tuberculosis and Lung Diseases, New Delhi India

#### Major findings:

83.56 % public places have signages out of that 82.21 % displayed at prominent places and 80.85 % have COTPA specific signages with designated person name. 92.72 % public places have no active smoking at the time of data collection and 90.57 % have no smoking Aids. Only 18.6 % of Public places of Darjeeling district have evidence of smoking. Overall the rate of compliance of the section -4 of COTPA,2003 in Darjeeling district is over 80 % compliance.

On the base of this research report the Darjeeling district has declared as West Bengal first smoke free district on 26th January, 2017.

6. An impact study of Adolescent Health training program on the awareness level of adolescents on menstrual health and Nutrition

Nature of Study: Impact study of awareness health program on adolescent health & nutrition organised by MANT in collaboration with VigyanPrasar, GOI

Area of Study: Purulia&Jalpaiguri, West Bengal

**Duration:** December 2016

**Objective:** The objective of the study was to see the Impact of training program for the adolescent girls on the awareness generation about their Menstruation health & nutrition intake.

#### Major Findings:

Almost all the girls after the training program accepted that changes occur in the adolescent period are different for boys and girls after the training program. It is observed that the training program was successful in generating awareness among the adolescent girls about the meaning of complete nutrition. Lastly, the training program was effective in making them understand that both the girls and boys should be treated equally.

7. The Impact of Demonetization on the sales and consumptions on cigarettes and Bidis: A case of West Bengal

Area of study: Kolkata &PaschimMedinipur, West Bengal.

Time of the Study: January - March 2017

**Objective:** To study the effect of sudden ban of 500 and 1000 denomination on the market status of different brands of cigarettes and Bidis in West Bengal.

Primary result: It is observed the sales of different cigarette brands have dropped remarkably within the 20 days of demonetization and the prices have adjusted accordingly with the fall in sales.

Note: Further evaluation of the data is going on and the results will be published accordingly.
