1	Vermicompost pit at 9ft X 8 ft X 0.83 ft	12
2	4/4" cement pole with bamboo framing, tin for shade, and Akchala (single slope), height 8ft	12
3	4/4" cement pole with bamboo framing, tin for shade, and Dochala (Double slope), height 10 ft	12
4	4/4" cement pole with wooden framing, tin for shade, and Dochala (Double slope), height 10 ft	12
5	Iron pole and Iron framing, tin for shade, and Dochala (Double slope), height 10 ft	12

Note: We can go forward with any onetype of shade (SI no 2-5), as per our budget.

2. Technical Specifications and Requirements

- a. Vermicompost Pits are-
 - 3-inch Concrete Flooring
 - 5-inch brick base
 - Two round 5-inch brick walls
 - Four Internal Chambers
 - Net cement and plaster all around (inside and outside)
- b. Tin for shade (Color/White) should be 25mm or more in thickness.
- c. **GST:** As applicable under Government norms, and must be clearly mentioned in the quotation.
- d. **Freight:** Delivery (at designated site) charges should be mentioned separately

3. Eligibility Criteria

- a. The bidder must be a registered firm/company.
- b. Experience in construction work is mandatory.
