**2. Technical Specifications and Requirements:**

- a. Model Preference: Samsung A8, Samsung A11, Redmi Pad 2, Realme Pad 2, Lenovo M11, or a similar range that matched the above-mentioned model's specifications.
- b. Both WIFI Cellular Support will be needed.
- c. Min 4GB/64 GB variance needed.
- d. **Physical Damage Warranty should be 1 year.**
- e. **The supplier must provide free operational training and handholding support.**
- f. **GST:** As applicable under Government norms, and must be clearly mentioned in the quotation.
- g. **Freight:** Delivery (at designated site) charges should be mentioned separately

- d. Purchase Order will be issued **within 7 days** of opening of quotation, unless delayed by unforeseen circumstances.

- e. The selected (L1) bidder will be issued a Purchase Order (PO) and shall be required to submit a Proforma Invoice within 3 (three) days of the PO date, explicitly confirming ready stock availability and commitment to timely delivery.
- f. In case of failure to comply within the stipulated timeline, or inability to confirm supply, the management reserves the right to cancel the award and proceed with the next eligible bidder (L2) without further delay.
- g. Delivery Timeline: **Within 3 (three) days from the date of receipt of payment** or within 7 (seven) days from the date of issue of the Purchase Order (PO), **whichever is earlier.**

In the event that the selected vendor is unable to adhere to the stipulated timeline or fails to confirm readiness for supply within a reasonable period, the Purchaser reserves the right to cancel or reallocate the order, in part or full, to the next eligible bidder (L2), without any further liability.
