2. Technical Specifications and Requirements

- a. Only the CP/IB brand is needed.
- b. Protein percentage should be strictly followed.
- c. Floating feed is needed, not sinking.
- d. 1.8 mm for Tangra, and 3 mm for IMC (Rohu, Katla, Mrigal), does not provide any feed for shrimps/prawns.
- e. **GST:** As applicable under Government norms, and must be clearly mentioned in the quotation (if applicable).

3. Eligibility Criteria

- a. Must be a registered fish feed vendor.
