**2. Technical Specifications and Requirements**

- a. Excavation shall be carried out using **JCB or Poclain machines**.
- b. Pond size shall be approximately **50 decimals (0.50 acres)**, However actual measurement should be mentioned in the quotation after site visit.
- c. The contractor shall be responsible for **complete execution**, including excavation, embankment consolidation, and obtaining **all necessary government permissions(district, block, and local / panchayat levels)**, wherever applicable.
- d. **GST**: As applicable under Government norms, and must be clearly mentioned in the quotation (if applicable).

**3. Eligibility Criteria**

- a. Experience in excavation work is mandatory.
